A CALL FOR *entries*

Laurel Arts is once again transforming the galleries at the Philip Dressler Center for the Arts during the month of October.

This exhibit will showcase the art forms of special effects makeup, fabrication and monster making, prop making, and other skillful techniques used in the world of the Haunt.

Workshops and speakers are planned throughout the exhibit.

Who is eligible to enter?

Special Effects Makeup Artists, Monster Makers, Fabricators, & Prop Makers.

Entry fees Procedures:

Maximum of 6 entries per artist and entries may not have been displayed at the Dressler Center for at least the past 3 years. For 1-3 entries: Non-refundable fee of \$25 made payable to Laurel Arts. For 4-6 entries: Non-refundable fee of \$35 made payable to Laurel Arts. Artwork should be original and able to stand securely.

If your work is 2-D in nature, it must be properly wired, sturdy and ready to hang (no sawtooth hangers). For freestanding pieces, the only size restriction is the doorways at 32" and there are 4-7 steps depending on which entrance you use. Two submission cards must accompany EACH entry. See examples. Please PRINT or TYPE. One card will be attached to the back of your work and the duplicate given to Laurel Arts staff at the time of registration.

Artists must offer at least one-half of their submissions for sale. For 3 submissions, 2 would be for sale. For 5 submissions, 3 would be for sale. Laurel Arts will transact all sales and sales tax. We will also retain a 30% commission on gallery sales. Please price your work accordingly. A W-9 will be provided to all artists upon check-in to fill out.

All work must be signed in at drop off and signed out at pick up with the staff.

Entries will be handled with all possible care, however the Philip Dressler Center for the Arts is not responsible for any loss or damage. Any items left on the premises after thirty (30) days from the close of the exhibit will become the property of the Philip Dressler Center for the Arts. Laurel Arts reserves the right to reject work that does not meet the exhibit requirements.
